Get ready to submit your 2026 Pinnacle Awards entries when the live entry window opens on **Thursday, April 9**. Entry deadline is 5pm CT on Tuesday, April 28, 2026.

Our 2026 criteria & rules document, including “must have aired” dates and a tutorial on the “Rock Our Awards” entry portal, [can be found here](#).

### New for 2026

**BEST PODCAST** (3 entries/station, max.) Recognizes outstanding audio (Radio) or video (TV) storytelling created specifically for on-demand podcast platforms. Submissions must be original works produced for on-demand consumption, not rebroadcast or edited versions of previously aired content. Submissions cannot exceed 7 continuous minutes in length.

**BEST USE OF SOCIAL MEDIA PLATFORMS** (3 entries/station, max.) Recognizes an outstanding compilation of social media content to connect with audiences and inform the public. Representing one story or topic, each submission must include at least two and up to four URLs to the relevant social media posts.

“Best Election Coverage” will return in 2027.

Professional entries remain just \$30 each with 100% of the proceeds going to the NBA Foundation scholarship fund.

We look forward to seeing who will be recognized among the best of the best in Nebraska broadcasting, to be celebrated during our Pinnacle Awards banquet on the evening of Wednesday, August 12 at the Embassy Suites in Lincoln, co-sponsored by Pinnacle Bank and Nebraska Public Power District.

### NBA Board Members Join Fellow Broadcasters on Capitol Hill

NBA board members participated in the annual State Leadership Conference hosted by the National Association of Broadcasters (NAB) in Washington, DC from March 2-4. Nearly 600 broadcasters from across America attended the fly-in, which culminates in meetings with our respective federal delegates.

## Nebraska Legislature Update



As the clock keeps ticking on the 2026 Nebraska Legislature, the NBA continues working to protect our members' business interests with the ongoing guidance of lobbyists **Korby Gilbertson, Justin Brady** and our board of directors.

At the time of publication, it appears doubtful that we will face any new tax legislation during the remaining days of this "short" session.

However, with continued predictions of steep budget challenges in the near future, we will remain watchful and engaged before 2027 rolls around as the search for a broader tax base becomes an even higher legislative priority. Regarding "Winner Take All" it remains to be seen if [LR24CA](#) will advance as a ballot initiative. Regarding Open Meetings and Public Records, it appears that we will emerge from this session without losing any significant ground in our ongoing quest for FOI access.

## Transactions & Sign-Offs

Jeff Warshaw's **Connoisseur Media** announced a deal to purchase **NRG Media's Lincoln** radio stations. Pending FCC approval of the sale with a waiver to allow ownership of 11 stations in the market, Connoisseur would add NRG's KBBK (107.3 FM & 94.5 FM translator), KFGE (98.1 FM) KLIN (1400 AM) and KLNC (105.3 FM) to its recently acquired cluster of the former Alpha Media Lincoln stations.

**NRG Media** announced the divestiture of its remaining Omaha stations. **Usher Media** has agreed to purchase KOIL (1290 AM), KOPW (106.9 FM), KOZN (1620 AM), KQKQ (98.5 FM) and KZOT (1160 AM) for \$2.15 million. **Nebraska Public Media** has agreed to purchase KOOO (101.9 FM) for \$1.2 million. Both transactions are pending FCC approval. Late last year, NRG reached agreement to sell its Grand Island and Kearney stations to Usher Media. That transaction is still pending FCC approval.

Nebraska has two fewer AM stations on the air. Connoisseur Media – Columbus signed **KTTT** (1510 AM) off at the end of 2025 with a special temporary authority request to the FCC while the company “considers future operational plans.” SummitMedia ceased operations of Omaha's **KXSP** (AM 590) on February 20 as a result of selling the land from which the station transmitted.

Chairman **Mark Jensen** called the meeting to order at 8:33 a.m. and recited our Antitrust policy.

Following Hall of Fame advocate presentations, the board's discussion resulted in **John Knicely, Kevin Kugler, Steve Lundy** and **Ken Siemek** being elected for induction as our class of 2026.

Minutes from the November 5, 2025 meeting were approved. Financial reports for October, November and December 2025 were approved as presented by Secretary-Treasurer **Jeffrey Steffen**.

Timm provided an update on federal legislative & regulatory concerns before lobbyist **Justin Brady** of Radcliffe Gilbertson & Brady joined the meeting with an update on state legislative matters.


Discussion resulted in agreement to explore added communication support for member engineers and a potential "digital ambassadors" program.

## John Knicely, Kevin Kugler, Steve Lundy & Ken Siemek to join NBA Hall of Fame on August 11 in Lincoln

The Nebraska Broadcasters Association will induct **John Knicely, Kevin Kugler, Steve Lundy** and **Ken Siemek** into the NBA Hall of Fame on **August 11th** in Lincoln during the NBA Annual Convention. Established in 1972, the NBA Hall of Fame will grow to 127 members with these pending inductees.



From his start as a TV sportscaster through his 34 years as news anchor on Omaha's WOWT TV, **John Knicely** set a long-term standard for credibility and trust in Nebraska's most competitive television market before retiring in 2025. With a focus on stories that mattered to the community such as public safety and local government accountability, John's calm delivery also reassured viewers in uncertain times such as tornadoes, terrorist attacks and the 2020 Covid-19 Pandemic. No matter the day's news, John shared his commitment to uplifting stories through his popular "John at Work" and "Knicely Done"

features and earned numerous industry awards over his 50-year career. John took pride in teaching young reporters, anchors and producers to leave their opinions and egos at the door, setting future TV journalists up for success

**Kevin Kugler** has the most extensive play by play resume of any Nebraskan, and he continues scaling new heights on a national level. He began by doing play by play on KAWL in York and hosted "Big Red Wrap Up" and other programs on Nebraska Educational Television. Kevin hosted "Unsportsmanlike Conduct" on Omaha's KOZN for 12 years and is the former radio voice of the UNO Mavericks football and basketball teams. As a play by play announcer for FOX, Kevin has called over 100 NFL games since 2020 along with college basketball, Major League Baseball, the UFL and other events. On the Westwood One Sports network, Kevin calls the NFL, college basketball and other sports. Kevin has been the radio voice



of the NCAA Men's Final Four since 2008 and he has also been calling college basketball on the Big Ten Network since 2012.



In a career approaching 50 years and still counting, **Steve Lundy** has entertained listeners and served local communities on some of Nebraska's most legendary radio stations. He got his on-air start in 1977 at KHUB in Fremont and over the next 23 years, Steve was heard in Omaha on WOW, KOIL, KEFM, KQKQ and KKAR. After four years on Lincoln's KLIN, Steve joined Omaha's KXKT in 2004 where he currently serves as co-host of "Steve & Gina in the Morning." Steve has shaped the sound of radio in Nebraska on a variety of formats and has influenced decades of

up-and-coming broadcasters. Beyond the dozens of industry honors Steve has earned, leading through community service on KXKT is his priority. When he is not on the air, Steve dedicates his time to reading to area grade school classrooms and helping at-risk elementary school students.



Over the course of his 44 years on KOLN (Lincoln) & KGIN TV (Grand Island), meteorologist **Ken Siemek** retired in 2025 after leading the stations' weather department through massive technology changes, going from handwritten weather symbols and temperature readings to the latest in radar and satellite weather forecasting technology. Ken helped to keep central and eastern Nebraska residents safe through countless life-threatening weather events, including the October, 1997 snowstorm that left Lincoln without power for days, the 2004 Hallam tornado, the statewide floods of

2019 and the Arbor Day 2024 tornado outbreak. When the storms rolled in, Ken's voice became the sound of safety; his warnings saved lives and his steadiness calmed fears. Ken also mentored fellow anchors and young reporters, teaching positivity and compassion to others.

## Technical Upgrades in Progress at UNL & UNO



Using funding provided by the NBA, our friends at UNL and UNO are making substantial technical improvements to allow their students to work with the latest technology as they prepare to enter the workforce.

**At UNL**, a complete renovation of the KRNU studios is underway. The \$900,000+ project was funded in part by a \$100,000 contribution from the NBA. KRNU Technical Director **Jamie Wenz** provided us with this update:

The KRNU renovation is in progress. To minimize the impact on students, we're doing the work in two phases. A construction crew is on site doing windows, electrical, drywall, lighting, HVAC and sound proofing in those areas. The main control room for KRNU remains intact and operational, along with two of our audio booths so we can keep on the air. Three temporary audio booths have been set up in various locations in our building. The first phase of construction should take wrap up in early April.

Broadcast Depot will be here next week to begin configuration and installation of our new equipment. We will build the main server racks for the new equipment in our designated server room and prepare all of the equipment for our audio booths while they are here. Once construction on phase one has finished, we will set up temporary furniture in those rooms and hook up our new Telos audio equipment. This will allow us to use the new equipment to keep us on air when phase two of our construction starts on the main audio studio for KRNU and the remaining two audio booths. The whole project is scheduled to be completed in late May.

**At UNO**, an NBA contribution of \$50,000 is funding a significant overhaul of their lighting systems. UNO Television Producer/Director **Lyle Kwiatkowski** shared this status report:

In phase 1 of funding, we were able to fully retrofit our studio fixtures to LED and add a few additional fixtures to give us some helpful redundancy while also reducing the number of fixtures in the ceiling.

During the second phase, we purchased new lighting relays for the dimmer rack so the LED fixtures would work properly with our existing incandescent dimmer system in addition to hiring a sub-contractor to assist with the re-hanging of the fixtures.

Looking ahead to the next phase, we plan to purchase more relays so that every power outlet in the studio can support an LED fixture. After that, we'll turn our attention to adding floor lighting, which will give us more flexibility when lighting subjects from the ground up.

NRG Media-Lincoln's **KFGE** ("Froggy 98") was among the 50 finalists and was represented at the event by Program Director **Cory Edmondson**



"Yacht Rock" set sail in Omaha on January 2. NRG Media's **KZOT** (1180 AM) flipped to the "Light Classic Hits" format after 13 years as a syndicated Sports-Talk station, followed by roughly seven weeks of stunting as a Christmas music station before the change.

After more than 65 years on the air – including the last 20 on Walnut Media's **KHUB** in Fremont – **Bob Flittie** retired after his last broadcast on March 13.





Following a broadcasting career spanning more than 40 years, **Kevin Cooper** called it a career after the March 20 **KTIC-AM** morning show. On March 23, **Connie Green** began her new role as News Director and Morning Show Host on KTIC.

Several retirements at the UNL J-School: **Rick Alloway**, **Laurie Lee** and **Barney McCoy** have provided a tremendous broadcasting education to thousands of students at the University of Nebraska – Lincoln’s College of Journalism and Mass Communications over the past several decades. McCoy retired at the end of the fall 2025 semester. Alloway and Lee will retire at the end of the current spring semester. Thank you for all you have done for your students and for the NBA!

**Chase Porter** of NRG Media - Lincoln's KLIN news team was one of 30 journalists from across the country who earned a fellowship to attend last week's Media Law Program at the University of South Carolina. Porter said: *"We received a crash course in the U.S. criminal justice system and its intersection with our work as reporters. The program covered the foundations of criminal and civil law, courtroom access, public records, and the evolving boundaries of First Amendment protections. One of the clearest takeaways was how those boundaries are being tested by the unique pressures of our time. It was a reminder that doing this work well depends on understanding the laws that protect a free press, and our willingness to assert those rights when they're challenged."*

### 1966: 60 Years Ago

NBA Veep **Roger Larson** (KFOR) and Sports Chairman **Dave Young** (KSID) want to thank all stations for their cooperation on the Nebraska High School Basketball Tournament in Lincoln and Omaha: **Mort Fleischl** (KBON) handled NBA arrangements in Omaha. He reports that stations KBON, KFAB, KFOR, KHAS, KHUB, KLIN, KNCY, KNEB, KOLT, WOW, KMTV and KETV checked in with him and were issued press and/or broadcast passes. **Larson** handled similar Lincoln tournament chores for the following stations: KFAB, KBRL, KFOR, KHAS TV, KMMJ, KLIN, KWBE, KRFS, KTTT, KAWL, WOW, KRVN, KJSK, KHAS, KETV, KARNY, KHOL-TV, KUVR and KODY.

### 1976: 50 Years Ago

**WJAG owners on FCC divestiture list.** After studying local cross-ownership for nearly seven years, the FCC has issued an order which, among other things, requires the owners of the Norfolk Daily News, WJAG-AM and WJAG-FM to divest one of their properties within five years. Norfolk was one of only sixteen markets singled out in this fashion.

Nebraska Senator **Roman L. Hruska** is the author of a bill in Congress which would guarantee to broadcasting the full First Amendment rights now enjoyed by the print press, end discrimination between the electronic and print media in certain areas and eliminate the "Fairness Doctrine". It would amend the Communications Act of 1934 and several sections of the U.S. Code covering the federal government's advertising policies. The bill would prohibit the Commission from requiring broadcast licensees to set aside broadcast time for particular purposes or persons or from controlling programming content, prevent the FCC from revoking a station's license because the licensee did not provide access to candidates for federal office, repeal Section 315 of the Communications Act, including the provisions requiring "equal opportunities" and lowest unit rate charges for uses of station facilities by political candidates. It would permit licensees to cover controversial public issues without being compelled to provide balance or present contrasting viewpoints.

## 1986: 40 Years Ago

**Gary Nielsen** will manage Channel 42, a Pappas independent station in Omaha. The format will include daytime children's programs, movies and syndicated reruns. The station will be in direct competition with Omaha's three network stations. Work has begun on a transmission center in Sarpy County just north of Springfield.

The first song broadcast when **KBWH FM**, Omaha went back on the air was "Ain't No Stopping Us Now." The station was knocked off the air Dec. 17 by vandals who apparently climbed over a fence and tore a panel from the transmitter shed. Once inside, they ripped a battery from its housing, spilled battery acid into the transmitter and stole electrical equipment and some lights.

## 1996: 30 Years Ago

NBA Freedom of Information Chair **Steve Murphy** has named a subcommittee of members who will represent the FOI committee in their respective areas. These members will respond to FOI access problems which might arise during the year. They were selected because of their understanding of local issues. Subcommittee members are **Jim Curry**, WJAG/ KEXL, Norfolk; **Bob Brogan**, KRVN, Lexington; **Kevin Mooney**, KNEB, Scottsbluff; **Dale Johnson**, KFOR, Lincoln; **Tracy Overstreet**, KRGI, Grand Island; **John Cox**, KOOQ/KELN, North Platte; **John Clark**, WOWT, Omaha; and **Steve Murphy**, WOWT, Omaha (retired).

## 2006: 20 Years Ago

**Jim Timm** has been promoted to station manager of the Journal Broadcast Group's Omaha radio stations, as General Manager **Steve Wexler** has taken on additional management duties as a result of the Journal acquisition of KMTV, Omaha. Timm has been with Journal since 1997, first as GSM at WKTI-FM in Milwaukee and most recently as DOS of Journal's Omaha radio cluster.

KLIQ (94.5 FM) Hastings has been purchased by **Platte River Radio, Inc.**, owners of KKPR FM/KXPB AM, Kearney, from Eternal Broadcasting, which had been operating the station under an LMA to NRG Radio. Additionally, KHAS 1230 AM and KICS 1550 AM, Hastings, have been sold to Platte River. **Dave Brock**, current GM of KLIQ is managing the three-station cluster for Platte River according to owner/GM **Craig Eckert**.

## 2016: 10 Years Ago

KFOR (Lincoln) News Director **Dale Johnson** was seriously injured when struck by a car while riding his motorcycle on March 20th in Lincoln. Dale continues to improve, however, due to the severity of the accident the doctors had to amputate his left leg above the knee. While horrible news, Dale remains in strong spirits and is thankful to be alive. He is showing progress every day and is already planning his return to KFOR.

**Gray Television** recently closed on its purchase of Schurz Communications. The deal includes the acquisition of **KNEP-TV** – the former **KDUH-TV** on Channel 7 – and plans for expanding local service to viewers in the Nebraska Panhandle. KNEP-TV continues to carry ABC and other programming from **KOTA** in Rapid City on Channel 7. In a few months, Gray will add NBC and Nebraska news, weather, and sports content to a "subchannel" of the station that should be visible to everyone who now receives KNEP-TV on Channel 7.
